29	The updated plans and sections for the year 2015-16, as required under rule 28 has not been submitted to the Controller General IBM Nagpur, Controller Mines (CZ) IBM Nagpur and the Regional controller of Mines, IBM Ranchi, which has to be submitted on or before 30 th June 2016.
42(1)(c)(i)	Since, the mine falls under category –A (Other Than Fully Mechanised), a full time Mining Engineer holding degree in mining engineering has not been employed to carry out mining operations as required under the rule

- 02. In this connection, it is brought to your notice that the above violation constitutes an offence punishable under Rule 58 of MCDR, 1988.
- 03. You are, therefore, advised to rectify the above violations immediately and intimate the position to this office within 45 (forty five) days from the date of issue of this letter.
