Sub:- Violation of provisions of Mineral Conservation & Development Rules, 1988 in respect of your DBS Bauxite Mine M.L.No-1055/2640 over an area of 327.01 Ha. situated in Navage-Village, Belgaum-Tq, Distt.-Belgaum, Karnataka-State.

Sir,

The following provision of Mineral Conservation & Development Rules, 1988 was found violated during the inspection of your above mine on 13/12/2015 AN by the undersigned.

Rule	Nature of Violation Observed
24(1)	It was observed during inspection that mining operations in the lease area were temporarily closed due to statutory clearances etc.but the notice in form D-1 has not been submitted even after more than 90 days from temporary discontinuance to IBM Goa office.
29	The owner, agent, mining engineer or manager of every mine shall, ¹ [on or before the 30 th day of June] every year submit to the Controller General, Controller of Mines and the Regional Controller a copy of the plans and sections maintained under rule 28.
23(E)(2)	A yearly report before 1 st July of every year setting forth the extent of protective and rehabilitation work carried out as envisaged in the approved progressive mine closure plan has not been submitted to this office.
63	A Self-Appraisal Report to be submitted by Owner of the mine under Rule 63 of MCDR, 1988 stating extent of implementation of Approved Mining Plan/Scheme of Mining during the year of 2012-13 along with supporting plans/sections, representative photographs in hard as well as soft copy.

02. In this connection, it is brought to your notice that the above violation constitutes an offence, punishable under Rule 58 of MCDR, 1988.

03. You are advised to rectify the above violation immediately and intimate the position to this office within 45 (forty five) days from the date of issue of this letter.
