Sub: Violation of provisions of Mineral Conservation and Development Rules, 2017 in respect of your Thummaluru Iron Ore Mine of over an extent of 148.74 ha. of Thummaluru Village, Pendlimarri Mandal, YSR Kadapa District, Andhra Pradesh State.

Sir,

The following provisions of Mineral Conservation and Development Rules, 2017 were found violated in your above mine during the inspection on 19.03.2022 in the presence of Shri. Ramakrishnaiah, Mine Representative, Sri. S. Tarun Kumar, Mining Engineer.

Rule No.	Nature of Violations observed
11 (1)	No holder of a mining lease shall commence or carry out mining Operations in any area except in accordance with the mining plan approved, modified or reviewed by the Indian Bureau of Mines. Your Review of Mining Plan document was approved vide letter No. 659(539)/FE/2005/HYD dated 25/06/2018 and following deviations have been observed: It was proposed to plant 100 Nos. saplings 2021-22. However, during inspection it was noticed that plantation was not carried out as per the proposal.

02. In this connection, it is brought to your notice that the above violations constitute an offence punishable under rule 62 of MCDR, 2017. Further, inability to comply the provision of Rule 11(1) is liable for suspension of mining operations under 11(2) of MCDR, 2017.

03. You are advised to rectify the above violations immediately and intimate the position to this office within 45 (Forty Five) days from the date of issue of this letter.


