Sub: Violation of provisions of Mineral Conservation and Development Rules, 2017 in respect of Venkatapuram Limestone Mine of Smt. S.Kalavathamma over an extent of 4.99 ha situated in Venkatapuraram Village, Banaganapalli Mandal, Kurnool District of Andhra Pradesh State.

Sir,

The following provisions of Mineral Conservation and Development Rules, 2017 (MCDR, 2017) were found violated in your above mine during inspection of the mine on 30.04.2022 by Sri A V Ramesh Kumar,AMG of this office, accompanied by your Sri B.Lakshmanna,Mining Engineer.

11(1)	<p><i>No holder of a mining lease shall <del>commence or</del> carry out mining operations in any area except in accordance with the mining plan approved, modified or reviewed by the Indian Bureau of Mines <del>or prepared and certified in accordance with the system established by the State Government pursuant to the proviso to clause (b) of sub-section (2) of section 5</del></i></p> <p>Mining operations are not being carried out in accordance with the proposals given in approved Mining Plan vide letter no. AP/KNL/MP/LsT-138/Hyd. dated 17.05.2021 to the extent indicated below:</p> <p><b>“It was proposed to carry out 10(TEN) DTH Boreholes during the year 2021-22.However, no such exploration was carried out”.</b></p>

02. In this connection, it is brought to your notice that the above violation constitutes an offence punishable under rule 62 of MCDR, 2017, further inability to comply the provision of rule 11(1) is also liable for suspension of Mining operation under the rule 11(2) of MCDR, 2017.

03. You are advised to rectify the above violations immediately and intimate the position to this office within 45 (Forty Five) days from the date of issue of this letter.
