Sub: Violation of provisions of Mineral Conservation and Development Rules, 2017 in respect of your Kakatiya Limestone Mine (38APR10004) over an extent of 121.41ha. of Budavada Village, Jaggayyapeta Mandal, Krishna District, Andhra Pradesh.

Sir,

The following provisions of Mineral Conservation and Development Rules, 2017 were found violated in your above mine during the inspection on 02.03.2022 in the presence of Shri. Ramana Reddy, Mine Manager, Shri. T. Dileep, Geologist and communicated to you vide this office letter dated 09.03.2022 by giving 45(Forty five) days time for compliance.

11 (1)	No holder of a mining lease shall commence or carry out mining Operations in any area except in accordance with the mining plan approved, modified or reviewed by the Indian Bureau of Mines.	Your Review of Mining Plan document was approved vide letter No. AP/KSN/MP/LST-28/HYD dated 24/03/2017 and following deviations have been observed: There was no proposal for stacking of minerals whereas during inspection it was found that limestone mineral has been stacked at various places in the working pit.
31 (4)	The plans and sections required under these rules shall be maintained up to date showing also the respective proposal of approved mining plan for various activities pertaining to that year, within three months in case of category 'A' mines as referred to in clause (a) of sub-rule of rule 55, and within twelve months in the case of any other mine.	The respective proposal of approved mining plan for various activities pertaining to that year were not shown in the plans and sections maintained.

02. Your reply vide your letter dated 20.04.2022, referred in Sl. No. ii has been duly considered and not found to be satisfactory for compliance of Rule 11(1) and 31(4).

03. It is again brought to your notice that the above violations constitute on offence purished and the selections

- 04. You are, therefore, directed to show cause within a period of 30 (thirty) days from the date of issue of the letter, as to why you should not be prosecuted for the above offence or the mining operations should not be suspended under Rule 11(2) of MCDR,2017.
- 05. Please note that no further notice will be given to you in this regard.
