Sub: Violation of provisions of Mineral Conservation and Development Rules -2017(MCDR-2017) in respect of your JSW Limestone Mine over an extent of 617.57 ha in Bilkalaguduru and Bujanur Villages, Gadivemula Mandal, Kurnool district of Andhra Pradesh.

Sir,

The following provisions of the Mineral Conservation and Development Rules -2017 (MCDR-2017)were found violated in respect of your above mine during the inspection on 15/2/2019 by the undersigned in presence of Sri S. Bose Mines Manager, Sri S.K.Shukla Mining Engineer and Sri Ritesh Chattaraj, Geologist of your mine.

Rule	Nature of violation observed

26(2)	The holder of mining lease shall submit to the competent authority a yearly report as per the format specified by the Indian Bureau of Mines, before 1st day of July every year setting forth the extent of protective and rehabilitative works carried out as envisaged in the approved mine closure plan.
	But it has been noticed that you have not submitted the said report to this office.
54	You are supposed to maintain the production register, sub-grade or mineral reject stack register along with the grade. However comprehensive production register showing ROM production, Subgrade
	generation, waste/ mineral reject generation, for the year 2017-18 has not been kept as per past practice in the mine.
46	Shri S.K.Shukla has been reported to be appointed as Mining Engineer under rule 55 of
	MCDR 2018, but the notice of his appointment has not been submitted.

- **02.** In this connection, it is brought to your notice that the above violation constitutes an offence punishable under rule 62 of MCDR, 2017.
- **03.** You are advised to rectify the above violations immediately and intimate the position to this office within 45 (forty-five) days from the date of issue of this letter.
