| 35(1) | Every holder of a mining lease shall submit online its self-assessment report before the 1 st day of July of every year for the previous financial year along with soft copy(in the standard format) as on 31 st day of March for that financial year to the Regional Controller of mines. |

| 55(1) | As per the rule, a part-time mining engineer and part-time geologist shall be employed in the mine. The same has not been appointed. |
