Further, on office records basis violation of rule 27(1) was pointed out & violation letter was issued on 01.06.18 but due to non-compliance of this violation, mine suspended on 07.09.18. Current inspection was carried out in connection with examination of submitted draft Final Mine Closure Plan and during inspection no violations were pointed out as the mine was non-working since long time and mined out area was completely reclaimed & rehabilitated. Cultivation over this area was being carried out as observed.
