The following provisions of the Mineral Conservation and Development Rules, 2017 were found violated in your above mine during the inspection made on 14.02.2018 by the undersigned in presence of Sh. K.P.Singh, Sr.GM(Mines)

Rule 11(1)	The mining operations are carried out in violation of following provisions of approved Modified
	Mining Plan (Approved on 08.06.2016): -
	1) Height of benches in OB as well as in mineral was proposed from 3m to 6m but in working pits at
	few places it was observed up to 9m.
	2) Terracing of waste dumps have not been carried out properly.
Rule 31(4)	Plans & sections required to be kept under rule 32 have not been maintained up to date within three months.

- 02. In this connection, it is brought to your notice that the above violations constitute an offence punishable under Rule 62 of MCDR, 2017 and in case of non compliance of the above rules following action may be initiated under MCDR, 2017:
 - (a) Mining operations may be suspended under rule 11(2) of MCDR, 2017.
 - (b) Prosecution may be launched against you.
- O3. You are advised to rectify the above violations immediately and intimate the compliance to this office on letter pad signed by the owner within 45 (forty-five) days from the date of issue of this letter.
