Sir,

Undersigned has issued violation letter of even number dated 22.08.2017 for below mentioned rules of Mineral Conservation & Development Rules, 2017.

**Rule 27(2)-**

Where financial assurance has already been furnished before the commencement of these rules under sub-rule (1), an amount equal to the difference between the financial assurance due as on the date of notification of these rules and the financial assurance already furnished, shall be furnished to the Regional Controller of Mines, as the case may be, within a period of ninety days from the date of notification of these rules. **But till date you have not submitted financial assurance for the differential amount in form of bank guarantee to this office.**

02. In this connection, it is brought to your notice that the above violations constitute an offence punishable under Rule 62 of Mineral Conservation and Development Rules, 2017.

03. The mining operations can be suspended under rule 11(2), if compliance of rule 11(1) is not found satisfactory.

04. You are therefore, directed to show cause with in a period of 30 (Thirty) days from the date of issue of this letter, as why should not be prosecuted for the above offences.

05. Please note that no further notice will be give to you in this regard.


