The following provision of Mineral Conservation and Development Rules, 2017 (hereinafter referred as MCDR, 2017) was found violated in your above said mine during inspection on 19/03/2019 by the undersigned. The inspection was accompanied by Sri Mukesh Kumar Agarwal, Agent and Sri Bachelan Kumar, Whole time Director of your organization.

26(2)	The holder of mining lease shall submit to the competent authority a yearly report....extent of protective and rehabilitative works carried out as envisaged in the approved mine closure plan, and if there is any deviation, reasons thereof:	Report on extent of protective and rehabilitative works carried out as envisaged in the approved mine closure plan has not been submitted to the Regional Controller of Mines, Bhubaneswar for the year 2017-18.

2. In this connection, it is brought to your notice that the above violations constitute an offence punishable under rule 62 of MCDR, 2017.

Besides, inability to comply with the provisions of MCDR, 2017 is also liable for suspension of Mining Operation under the provision of rule 11(2) of MCDR, 2017.

3. You are advised to rectify the above violation immediately and intimate the position to this office within 45 (forty-five) days from the date of issue of this letter.
