Sub: Violation of provisions of Mineral Conservation and Development Rules, 2017 in respect of your Kocheruvu Limestone mine over an extent of 22.096 ha in Sy.no. 571/F2-1 of Kocheruvu Village, Dhone Mandal, Kurnool district, AP state.

Sir,

The following provisions of Mineral Conservation and Development Rules 2017, were found violated in your above mine during Mining plan inspection on 13.2.2019 by Sri M.Pratap Reddy AMG accompanied by your representative Sri L.Srinivasulu and Sri Kishore Geologist.

Rule No.	Rule position	Nature of Violation
11(1)	No holder of a mining lease shall commence or carry out mining operations in any area except in accordance with the mining plan approved, modified or reviewed by the Indian Bureau of Mines or prepared and certified in accordance with the system established by the State Government pursuant to the proviso to clause (b) of sub-section (2) of section 5.	Vide Para 8.3.1, of approved review of Mining Plan vide Ir.no.AP/KNL/MP/Lst-118/Hyd dated 11.9.2017, it has been proposed to back fill the safety zone between boundary pillars viz. K-29 to K-21 to an height of 1.2m Against such proposal no backfilling has been carried out so far.
55(1)(c) (ii)	Every holder of a mining lease shall employ, in case of category B mines, a part time Mining Engineer and a part time Geologist.	You have not employed a part time Mining Engineer and part time Geologist has not been employed so far as per the provisions of the Rule submitted.

02. In this connection, it is brought to your notice that the above violations constitute an offence punishable under rule 62 of MCDR, 2017.

03 You are advised to rectify the above violations immediately and intimate the position to this office within 45 (forty-five) days from the date of issue of this letter.
