Subject: Violation of provisions of provisions of Mineral Conservation & Development Rules, 2017 in respect of you Chachandih bauxite mine in District of Anuppur in M.P. State over an area of 148.81 Ha.

Dear Sir,

The following provisions of the Mineral Conservation and Development Rules, 2017 were found violated in your above mentioned mine during MCDR inspection on 18/03/2021 by the undersigned in presence of Mr.Pandey, Mining Enineer and mines Manager Mr.R.P.Gupta

Rule 11(1)	No holder of a mining lease shall commence or carry out mining operations in any area except in accordance with the mining plan approved, modified or reviewed by the Indian Bureau of Mines or prepared and certified in accordance with the system established by the State Government pursuant to the proviso to clause (b) of sub-section (2) of section 5 or approved by the competent authority of the Atomic Minerals Directorate for Exploration and Research, in respect of minerals specified in Part B of the First Schedule to the Act where the grade of such atomic minerals is equal to or above the threshold value limits declared under Schedule-A of the Atomic Minerals Concession Rules, 2016. 1. Backfilling was not done in pit no 1 as per approved plan proposal.
	The working in pit no3 was not done as per approved plan proposal.
	3. Survival rate of plantation done in pit 3 backfilling is poor. (approx50%)
Rule 26(2) MCDR 2017	(2) The holder of mining lease shall submit to the competent authority a yearly report as per the format specified by the Indian Bureau of Mines, before 1st day of July every year setting forth the extent of protective and rehabilitative works carried out as envisaged in the approved mine closure plan, and if there is any deviation, reasons thereof: Statement/yearly report for progressive closure under this rule for yr 19-20 is not submitted.
Rule	General requirements about plans and sections
31(iv),	(4) The plans and sections required under these rules shall be maintained up to date within three months in case of
	category 'A' mines as referred to in clause (a) of sub-rule (2) of rule 55, and within twelve months in the case of any
	other mine.
	 Updated Surface plan and surface geological plan were not maintained /were not kept updated within 3 months as required under this rule.

02.In this connection it is brought to your notice that the above violations constitute an offence punishable under Rule 62 of MCDR-2017.

03. You are advised to rectify the above violations immediately and intimate the position to this office within 45 (Forty-Five) days from the date of issue of this letter.
