This office is in receipt of three copies of the above-mentioned draft Review and Updation of Mining Plan including Progressive Mine Closure Plan on 18.04.2019. On examination of the same the discrepancies / deficiencies observed have been listed in annexure.

You are advised to correct the submitted Mining Plan including Progressive Minc Closure Plan as per deficiencies /discrepancies pointed in the enclosed annexure as scrutiny comments and submit 3 fair copies of the Mining Plan including Progressive Minc Closure Plan within 15 days from the date of issue of this letter after corrections in hard bound copies (no spiral binding). If the fair copies of Mining Plan including Progressive Mine Closure Plan will not be submitted within stipulated time, final action will be taken as per rule. Two CDs of the fair Mining Plan including Progressive Mine Closure Plan may also be submitted including text, plates and annexures. On receipt of additional comments from State government, it shall be communicated to you subsequently. In case if it is necessary to incorporate the additional information, the details of the same should be given along with page numbers.

You are further advised to prepare the fair copies carefully and ensure that it is correct in all respect. Preferably use of paper on both the side should be made. If again deficiencies are observed then final action will be taken by this office without returning the copies for correction. This issues with the approval of competent authority. Encl; as above.

(144.25 hect.) in Srinagar district of J&K State submitted under Rule 17(1) of MCR 2016 & 23 of MCDR 2017. (DoR 18 April 2019.

- On cover page the lessee name is indicated as Mr. Manzoor Ahmad Guna. Status of lessee should be as
 per lease deed document(s). Further no valid document enclosed in favour of the indicated lessee. Name
 of lessee should be as per legally valid document and also be specific as per supporting legally valid
 documents.
- Cover page- only mention that lease period which is Valid lease period substantiated with supporting document. Lease period- under process- Not to be written. Similarly in the consent letter name of lessee should be as per lease deed.

3. On cover page proposal period is given from April 2019 to 2022-23. Proposal period should be given from 2019-20 to 2023-24 i.e. for ensuing five years..

4. As per practice Comments were sought from the State government on mining plan submitted earlier (which was not approved vide letter dated 3/7 January 2019). The comments from **State government** are attached herewith for needful.

5. Page 2- Name of lessee- No supporting document attached.

- Page 2: Status of Lessee has been changed from previous submission. Legitimate status shall only be mentioned.
- 7. Page 3- Name of Mine shall be as per Form-I, furnish the same.

8. Comments on

- Production for the first year should be reduced proportionately since two and half months would be over for the FY 2019-20.
- Page 15- Year 2019-20 shall be considered as first year. Accordingly financial assurance shall be submitted to terminus with the mining plan period.
- 11. Page 15- Boreholes are not on grid. Form J of BH drilled for exploration is not given. Details of BH for exploration shown in section to be given.
- 12. In the previously approved scheme of mining area put to use has been indicated as 14.21 hectares whereas in the present submission it is mentioned that 7.56 hectares of area has been rehabilitated which is not reflected from any of the yearly report under rule 26(2) of MCDR 2017 thus area rehabilitated covering an area of 7.56 hectares is not evident and cannot be considered. Accordingly the financial assurance calculated and submitted is not as per rules. Area put to use and FA should be calculated afresh and be submitted accordingly.
- 13. Compliance of rule 12(4) of MCDR 2017 is not evident from SGP and sections.
- 14. Previous scrutiny comments 10 (a), 11, 21, 44, 47, 49, 51 and 68 not attended. (Copy of previous Scrutiny comments is also attached for ready ref.
- 15. All the proposals should be made within the ML only.
- 16. All the annexures should be attested by qualified persons for their authenticity.
- 17. Two CDs covering the entire document and plans should be enclosed at the time of final submission. Undertaking in this regard by the qualified person should be given that the CD contains the same text & plates as submitted in hard copy.

- 18. Above comments be also referred which indicates deficiencies in various plan and sections.
- 19. Name of lessee on the plan should be as per lease deed and also give the reference to it.
- 20. B1, B2 is indicated on surface geological plan which is not clear as to what is referred..
- 21. Financial Area Assurance plan- Only area put to use be shown and nothing else. Give a table over it showing calculation of FA. Note that reclamation always pertains to the area which has been earlier used for mining.
- 22. One composite section shall also be given for all five years for proposed excavated area.
- Except Environmental Plan, all other plans & sections should be restricted to mine lease area only. No
 proposal should be made outside the ML area.
- Sections depicting year wise excavation proposals shall be superimposed on geological sections only. No new arbitrary section to be given.
