This office is in receipt of two copies of the above mentioned draft Modified Mining Plan including Progressive Mine Closure Plan on 19.08.2019. On examination of the same the discrepancies / deficiencies observed have been listed in annexure as scrutiny

You are advised to correct the submitted Modified Mining Plan including comments. Progressive Mine Closure Plan as per deficiencies /discrepancies pointed in the enclosed annexure as scrutiny comments and submit 3 fair copies of the Modified Mining Plan including Progressive Mine Closure Plan within 15 days from the date of issue of this letter after corrections in hard bound copies (no spiral binding). If the fair copies of Modified Mining Plan including Progressive Mine Closure Plan will not be submitted within stipulated time, final action will be taken as per rule. Two CDs of the fair Modified Mining Plan including Progressive Mine Closure Plan may also be submitted including text, plates and annexures. On receipt of additional comments from State government, it shall be communicated to you subsequently. In case if it is necessary to incorporate the additional information, the details of the same should be given along with page numbers.

You are further advised to prepare the fair copies carefully and ensure that it is correct in all respect. Preferably use both side of paper. If again deficiencies are observed then final action will be taken by this office without returning the copies for correction. This issue with the approval of competent authority.

Scrutiny comments indicating deficiencies in respect of Modified Mining Plan with PMCP of Bhootmarhi limestone mine of Mr. V.K Walia (32.57 hect.) in Bhootmarhi District-Sirmour of Himachal Pradesh State submitted under Rule 17(3) of MCR 2016 & 23 of MCDR 2017.

- Lessee details shall be as per executed lease deed only.
- On page 6, Para no 2.a (IV) lease expiry date is not matching with supporting document, lease renewed up to 24.04.2025. Correct details to be given.
- On page 9, Para no 3.1 written this is a review of Mining Plan submitted under rule 17(1) of Mineral Concession Rules 2016 but this is a Modified Mining Plan. Which is submitted under rule 17(3).
- Under review chapter on page no 10 Para no 3.1 (v) the plantation carried out outside the lease will not be considered for execution of proposal.
- 5. Page no 12. Para 3.5 reason for modification in mining plan has not been written.
- UNFC codes assessed to various Reserve & Resources are not appearing correct.
 How the reserves have not been considered under 111 category when the mine is operational from many years
- Future exploration proposal should be incorporated in the light of Rule 12(4) of MCDR-2017.
- Under Geology and Exploration chapter many mistakes have been done, such as in place of probable reserve it written proved mineral reserve and similarly in place of inferred mineral resource it indicated mineral resource written. Correct it
- On page no 20 Azimuth and dip need to be review in light of ultimate pit configuration.
- 10. Under mining chapter on page no 36, it is mentioned that year wise development plan have been prepared on scale 1:2000 while on plates 1:1000 have been mentioned.
- Under mining chapter at page no 37 Para 2.B written, while proposing of extraction of limestone around 3.14.465 tonne of shale also extracted during this year from 1420 MRL to 1380 MRL in 5 benches. But as per excavation proposal no waste generate during the plan period. This is contradictory.
- On page no 40, it is mentioned 1, 39,762 cum shale waste will be generate during the year 2020-21 but no shale production during the year 2020-21.
- 13 Use of mineral on page 47 is not defined correctly. Mentioned the name of consuming industries.
- Correct rule of PMCP should be mentioned on page 53 as per latest notified MCDR-2017.
- 15. On page no 57, additional area required for plan period is 0.3694 ha mentioned which is contradictory. Financial assurance calculation table where additional area during plan period mention is 1.7929 ha.
- On page no 57 para 8.3.01 table no 36, expenditure on various monitoring measurement is nil, which is not correct.

- On pages 58 and 60 incorrect year mentioned of year wise table Proposal for progressive mine closures plan.
- 18. HEMM shall be deployed as per bench design parameter.
- 19. Lease corner points shall be authenticated by state govt.
- Feasibility study report has not been enclosed with annexure.
- Annexure No-5 is not found attached.
- Ground vibration monitoring report not attached in annexure.

Plates:

- 23. Authentic lease plan shall be the basis for the preparation of all the plans and sections. There should not be any deviations in all the plans and sections with respect to configuration given in the lease plan.
- 24. Precise superimposition of authentic lease plan is to be carried out before preparation of all the plans and sections.
- 25. Ultimate pit limit not shown in surface plan.(Plate No 2).
- 26. Black dotted line showing in surface plan not mentioned in the index, what is the purpose of this line, standard color code should adopted as per Rules/Regulations under mine act.(Plate No 2).
- Sections are not matching with surface geological features especially of southern portion where alluvium is shown.
- Exploration limit G1, G2, G3 and G4 not showing in Geological Surface plan. (Plate No 3).
- Reserves & Resources as mentioned is on very higher side and UNFC code assigned in Geological section plate no 3A are incorrect.
- Year wise (2019-20 to 2021-22) proposal of excavation in plan is not clearly
 evident; the colour of string should be distinct. (Plate no 4A1., Plate no 4B1. Plate No
 and Plate No 4C1).
- 31. Predominant wind direction not shown in Environment Plan.(Plate No 6).
- 32. OB cump height and area of afforestation not show Environment plan (Plate No 6)
- 33. Plans and Sections shall be prepared as per rule 31 & 32 MCDR 2017.
- 34. Financial assurance plan is incorrect, sum of existing broken area and additional broken area not matched with the total broken area (Plate No-8).

General:-

- 35. All the plates should be attested by qualified persons for their authenticity.
- 36. All the annexure should be attested by qualified persons for their authenticity.
- Additional comments shall also be communicated to you in case of receipt of comments from State government if any...
- 38. There are several typographical mistakes which required to be corrected.
- 39. The mine is located in hill slope of the high altitude mountainous terrain susceptible for seismic & other ground movement. Hence adequate proposals should also be incorporated in the document like controlled blasting techniques, erecting retaining walls, check dams and parapet walls to ensure safe, secure and systematic mining for ensuing years.

- 41. All the proposal should be within mining lease area only.
