Sub: - Violation of provisions of Mineral Conservation & Development Rules, 2017 (Amended up to 3rd Nov 2021) in respect of your Gumgaon Manganese mines, over an extent of 35.97Ha. Situated in Gumgaon,-village, Teh-Saoner, District-Nagpur, State- Maharashtra.

Sir,

During scrutiny of Annual returns submitted to this office for the year 2020-21, following violations of MCDR 2017 were observed.

Rule	Nature of Violation observed
45(7)	<p>a) The land use details given in the Annual returns are not matching with the surface plan and details given in the approved document dated 22.10.2021. As per the surface plan about 0.3ha is occupied by the waste dump and area covered by plantation is 3.5Ha. however, in the AR area covered under dump is shown as zero and area covered under plantation(R &R) is shown as 3.1Ha.</p> <p>b) At point number 1 of part VI, Production of ROM is shown as 38939.590 T and opening and closing stock as zero. However, under grade wise production only 37,136.81T production is shown and nothing is shown for remaining 1802.78 tones. Generation of mineral reject is also mentioned as zero.</p> <p>c) In the AR submitted for the year 2020-21, at point no-2. of part VI, Dispatch of 35% to</p>

below 46% Mn ore is shown as 14746.060 T and dispatch of 46% and above Mn ore is shown as Nil. However, at point no 4 of same part (VI), for 35% to below 46% Mn dispatch quantity is shown as 14214.62T and for 46 % and above grade dispatch has been shown as 531.44T. There is a mismatch in dispatch figures given at point no 2 and 4 of Part VI.

d) For cost of production, Over-head cost value taken is not matching with the Over-head cost figures given in the AR under heading taxes and cesses. In the annual returns Rs 29,66,20,177 and ROM production is shown as 38939.590 T. based on this overhead cost per ton should be Rs 7617/T. However for cost of production overhead cost is mentioned as Rs 2183.39/T only. Further, in the capita cost Depreciation for the plant and machineries is shown as zero.

02. In this connection, it is brought to your notice that the above violation constitutes an offence, punishable under Rule 62 of MCDR, 2017.

03. The mining operations can be suspended under Rule 45(7) (a) (i), if compliance of MCD Rules 2017 (Amended up to 3rd Nov 2021) is not found satisfactory, or prosecution can be made, or both can be done.

04. You are advised to rectify the above violation immediately and intimate the position to this office within 30 (Thirty) days from the date of issue of this letter.
