Sub: Violation of provisions of Mineral Conservation & Development Rules, 2017 in respect of your Thimmapur Limestone & Dolomite Mine (ML No.2272/2481) situated in Mudhol Taluka, Bagalkot district of Karnataka State.

The following provision of Mineral Conservation & Development Rules, 2017 were found violated in your above mine during the inspection on 14/03/2019 by the undersigned in presence of Shri Shivam, Mine Manager and the same were communicated to you vide this office letter of even no. dtd, 16.03, 2019

11(1)	Mining operations have not been carried out in accordance with the Modified
	Mining Plan approved vide MP/MECH-98(KNT)/GOA//2016-17 dated
	01/02/2017.
	(i) It has proposed to work between the crosssections D-D' & E-E' by
	advancing 120 m towards north, East & south directions with two
	benches and by developing of one new bench at the pit bottom 542m RL
	in the year 2017-18.
	However, during the inspection it has observed that the aforesaid proposals
	were not achieved in the afforesaid year.
	(ii) As per the approved MMP, excavation were approved to be carried out
	by formation of regular shape of benches of height 6m and width more than the height.
	However, during the inspection it was observed that benches were merged in
	irregular manner and width of the benches were not maintained as approved at
	placesThis is not as per the systematic and scientific mining.
55(1)( c ) (i)	Appointment of Geologist was not made under this rule.
40	Holder of a mining lease shall take all possible measures to keep air pollution due
	to fines, dust or gaseous emmissions during, mining, beneficiation or other related

	activities within permissible limit.  However, during the inspection it was observed that the substantial measures to control the aforesaid parametres were not taken.
45(7)(a)	It has been observed in the annual returns 2017-18, that:-  (i) Lease area(surface area) utilization as at the end of year(Hectares):- work done under progressive mine closure plan furnished as 6.432 ha, but the was same not observed in the field.  (ii) In part V sec 3:- The Reserve and resource estimated at the end of the year :- a.) For limestone :- Mineral reserve has not been updated. b.) For Dolomite:- Reserve and resource were not furnished.  (iii) Material were sold to the some buyers without having IBM registration number.

- 02. The compliance reported by you, vide your letter no. Nil, Dtd-13/04/2019 in response to this office violation letter, dtd. 16.03.2019 has been duly considered; but **not found satisfactory** as the above violations have not been rectified so far.
- 03. In this connection, it is brought to your notice that the above violations constitute an offence punishable under Rule 62 of MCDR, 2017. Besides, inability to comply with the provision of Rule 11 (1) is also liable for suspension of mining operations according to the provisions of Rule 11 (2) of MCDR, 2017.
- 04. You are therefore directed to show cause within a period of 30(thirty) days from the date of issue of this letter as to why you should not be prosecuted for the above offence and/or the mining operations should not be suspended in accordance to Rule 11 (2) of MCDR, 2017.
- 05. Please note that no further notice will be given to you in this regards.
