11(1)	<p>Scheme of Mining was approved vide letter no. 279/954/2007/BNG dated 22.06.2015 for the period 2015-16 to 2019-20. The deviations observed in mining operations vis-à-vis approved document are given below.</p> <ul style="list-style-type: none">(i) It was proposed to drill 5 exploratory core boreholes during the year 2015-16, but the same was not yet carried out.(ii) During the year 2017-18, the proposed production was 10000 tonnes, whereas the actual production during the year is reported as 1100 tonnes. The less production is not justified.(iii) During the year 2015-16, the construction of retaining wall, Garland drain, Gully checks were proposed. During the year 2016-17, one masonry check dam across the nallah in Southeastern side of the lease area, were also proposed, but not carried out the same till now.
46	<p>As per the rule, every holder of mining lease shall send a notice of appointment of a whole-time mining engineer and a geologist under sub-rule (1) of rule 55 of MCDR 2017 , but no such appointment has been carried out.</p>

02. In this connection it is brought to your notice that the above violations constitute an offence punishable under Rule 62 of MCDR, 2017.

03. You are advised to rectify/explain the valid reasons for the above violation immediately and intimate the position to this office within 45 (forty five) days from the date of issue of this letter.
