	The deviations observed in mining operations vis-a-vis approved document are given
	below:
	(i). The proposed development & production for the year 2017-18 and the current year
	2018-19, given in plan & sections of plate No. 6A &6B, that as per the field observation
	made on the day of inspection reveals that the development workings are being carried out
	without keeping the extent of development proposed from the boundary of NNW to the
	middle of the ML area as marked in the Plate 6A, same is continuing even in the 2 <sup>nd</sup> year
	without extending the development towards NNW.

- 02. In this connection, it is brought to your notice that the above violations constitute an offence punishable under Rule 62 of Mineral Conservations and Development Rules, 2017.
- 03. You are, therefore, advised to rectify the above violations immediately and intimate the position to this office within 45 (Forty Five) days from the date of issue of this letter.
