Subject: Violation of provisions of Mineral Conservation & Development Rules,2017 in respect of your S.V. Chetty Iron Ore Mine, ML No. 2604, of over an extent of 60.00 Ha. in Jaisingpur Village, Sandur Taluk, Ballary District of Karnataka State

Sir,

The following provisions of the Mineral Conservation and Development Rules, 2017 were found violated in your above mine during inspection on 06.09.2018 by undersigned in presence of S/Shri Laxmikanth –Mines Manager, B. Ekabarappa –Mining Engineer and other mining officials:

Rules	Nature of Violations observed
11(1)	As per the approved Modified Mining Plan with Progressive Mine Closure Plan, approved by IBM vide letter no. 279/412/93/BNG dated 22/06/2016, for the period of 2016-17 to 2019-20: 1. Exploration by 10 nos. of DTH holes was proposed during F.Y. 2017-18, against which 8 nos. of DTH holes were carried out by the lessee during said period. 2. Exploration within subject lease hold area has not been carried out or proposed by the lessee “up to 300 meters or up to discontinuance of ore body, whichever is earlier” as per the requirement made under Rule 12(4A) (b) of Mineral Conservation and Development (Amendment) Rules, 2018.
35 (2)	High resolution satellite images obtained from CARTOSAT-2 satellite LISS-IV sensor on the scale of cadastral map, as on 31 st March for that financial year, covering the mining lease and an area of 2 kilometres from the lease boundary was not submitted to the Regional Controller of Mines, IBM-Bangalore.

02. It is brought to your notice that violation of the above Rule constitutes an offence punishable under Rule 62 of MCDR, 2017.

03. The mining operations can be suspended under rule 11(2), if compliance of rule 11(1) is not found satisfactory.

04. You are advised to rectify the above violations immediately and intimate the position to this office **within 45 (Forty Five) days** from the date of issue of this letter.
