विषय Sub: Violation of provisions of Mineral Conservation & Development Rules, 2017 in respect of your Bhootmari Limestone Mine over an area of 32.57 ha located near Village Bhootmari in Sirmaur District of Himachal Pradesh.

महोदय Sir,

The following provisions of the Mineral Conservation & Development Rules, 2017 were found violated in your above mine during the inspection made by the undersigned on 26.09.2019 in the presence of Shri D.K. Sinha, Mines Manager .

RULE NO.	NATURE OF VIOLATION OBSERVED
11(1)	Mining operation are not carried out in accordance with approved mining plan to the following extent: The mining plan for this mine was approved on 26.04.2017. It was proposed in the approved mining plan that the width of benches shall be kept to 10 Mtrs each. Whereas it was observed that the width of benches were not maintained as per proposal.
26(2)	The holder of mining lease shall submit to the competent authority a yearly report as per the format specified by the Indian Bureau of Mines, before 1 st day of July every year setting forth the extent of protective and rehabilitative works carried out as envisaged in the approved mine closure plan, and if there is any deviation, reasons thereof : On perusal of office records it is observed that yearly report for the year 2018-19 has not been submitted to the competent authority by the holder of the lease in the prescribed in this office till date.

2. In this connection, it is brought to your kind notice that the above violations constitute an offence punishable under Rule 62 of MCDR 2017.
3. Mining operations can be suspended as per rule 11(2) in case of non compliance and it constitutes non compliance of Rule 11(1) of MCDR, 2017.
4. You are advised to rectify the above violations immediately and intimate the compliance position to this office within 45 days from the date of issue of this letter.
