विषय Sub: Violation of provisions of Mineral Conservation & Development Rules, 2017 in respect of your Barwana Limestone Mine over an area of 2.90 ha located near Village Barwana in Tehsil-Sangrah Sirmaur District of State Himachal Pradesh.

महोदय Sir,

The following provisions of the Mineral Conservation & Development Rules, 2017 were found violated in your above mine during the inspection made by the undersigned on 27.09.2019 in the presence of, your representative Mr. N.S Rana Mines Manager .

<u>RULE NO.</u>	<u>NATURE OF VIOLATION OBSERVED</u>
11(1)	Mining operations are not carried out in accordance with the proposals of approved mining plan to the following extent: (i) Chapter-2 page no 23 The height of benches in limestone was proposed 5 meter but bench height found was of 10 meter which is not maintained as per proposal. (ii) As per proposal during the year 2018-19, it was proposed to plant 80 no plantations, but plantation was not carried out as per proposal.
33	The holder of a mining lease shall, on or before the 30 th day of June every year submit to the authorized officer a digital copy along with a print copy of the surface geological plan and sections maintained under rule 32. However, the lessee has not submitted the copies of the plans and sections as per rules.
26(2)	The holder of mining lease shall submit to the competent authority a yearly report as per the format specified by the Indian Bureau of Mines, before 1 st day of July every year setting forth the extent of protective and rehabilitative works carried out as envisaged in the approved mine closure plan, and if there is any deviation, reasons thereof : On perusal of office records it is observed that yearly report for the year 2018-19 has not been submitted to the competent authority by the holder of the lease in the prescribed in this office till date.
54	The holder of a mining lease shall maintain various register as per rule, where the royalty assessment register, production register and dispatched register not found maintained.
54(a)	The holder of a mining lease shall maintain Details of contribution made to District Mineral Foundation and National Mineral Exploration Trust, where the details was not found maintained.

2. In this connection, it is brought to your kind notice that the above violations constitute an offence punishable under Rule 62 of MCDR 2017.
3. Mining operations can be suspended as per rule 11(2) in case of non compliance and js constitutes non compliance of Rule 11(1) of MCDR, 2017.
4. You are advised to rectify the above violations immediately and intimate the compliance position to this office within 45 days from the date of issue of this letter.
