Violation of provisions of Mineral Conservation & Development Rules, 2017 in respect of your Sangrah Limestone Mine over an area of 8.05.55 ha located near Village Sangrah in Sirmaur District of Himachal Pradesh.

महोदय Sir,


The following provisions of the Mineral Conservation & Development Rules, 2017 were found violated in your above mine during the inspection made by undersigned on 28.09.2019 in the presence of Shri D.K. Sinha, Mines Manager .

RULE NO.	NATURE OF VIOLATION OBSERVED
11(1)	Mining operation are not carried out in accordance with approved mining plan to the following extent: The mining plan for this mine was approved on 26.04.2017.As per proposal during the year 2018-19,mining operations were to be carried out in Pit -1 from 1880 MRL downwards with a height 10 mtr. During the course of inspection it was observed that benches have not been developed from 1880 downwards so far.
26(2)	The holder of mining lease shall submit to the competent authority a yearly report as per the format specified by the Indian Bureau of Mines, before 1 st day of July every year setting forth the extent of protective and rehabilitative works carried out as envisaged in the approved mine closure plan, and if there is any deviation, reasons thereof : On perusal of office records it is observed that yearly report for the year 2018-19 has not been submitted to the competent authority by the holder of the lease in the prescribed in this office till date.
33	The holder of a mining lease shall, on or before the 30 th day of June every year submit to the authorized officer a digital copy along with a print copy of the surface geological plans and sections maintained under rule 32. However, the lessee has not submitted the copies of the plans and sections as per rules.
45(7)	The holder of a mining lease has submitted incomplete or wrong information in annual return 1. In Part-IV Consumption of Explosive indicated nil but production of limestone during year 2018-19 is shown 61790 Ton.

2. In this connection, it is brought to your kind notice that the above violations constitute an offence punishable under Rule 62 of MCDR 2017.
3. Mining operations can be suspended as per rule 11(2) in case of non compliance and is constitutes non compliance of Rule 11(1) of MCDR, 2017.
4. The mining operation may be advice to the State Govt. for suspension of all the mining operation in this mine as per provision of Rule 45(7), in case of non compliance of Rule 45(7).
5. You are advised to rectify the above violations immediately and intimate the compliance position to this office within 45 days from the date of issue of this letter.
