

विषय Sub: Violation of provisions of Mineral Conservation & Development Rules, 2017 in respect of your Drang Rock Salt Mine over an area of 8.12 ha located near Village

Drang, Tehsil- Sadar, District-Mandi of H.P State.

महोदय Sir.

The following provisions of the Mineral Conservation & Development Rules, 2017 were found violated in your above mine during the inspection made by the undersigned on 15.11.2019 in

the presence of Shri Dileswar Kar, Mine Manager.

RULE NO.	NATURE OF VIOLATION OBSERVED
	1.Mining operation were not carried out in accordance with the mining plan approved, vide letter no 614(2)/MP-A-265/15 DDN dated 17.12.2015 to the extent that Geo technical study is to be carried out before commencement of the mining operations whereas mining operations found in operation without geo technical studies .Refer page no 33(Mining Plan). 2. Proposed exploration for precise delineation of the mineralization has not been carried out as proposed at page no 22. 3. Incline D-2 is not developed as per proposal in mining plan.
45(7)	The holder of a mining lease has submitted incomplete or wrong information in annual return 1. Ex Mine Price is not correct, as per sale value of rock salt Ex Mine Price is 9406 rs but it is indicated 9500 rs, which is wrong.
55	Every holder of mining lease shall employ a geologist in the mine. But geologist has not been appointed in the mine.

2. In this connection, it is brought to your kind notice that the above violations constitute an offence punishable under Rule 62 of MCDR 2017.

3. Mining operations can be suspended as per rule 11(2) in case of non compliance and it constitutes non compliance of Rule 11(1) of MCDR, 2017.

4. The mining operation may be advice to the State Govt. for suspension of all the mining operation in this mine as per provision of Rule 45(7), in case of non compliance of Rule 45(7).

5. You are advised to rectify the above violations immediately and intimate the compliance position to this office within 45 days from the date of issue of this letter.
