

विषय Sub: Violation of provisions of Mineral Conservation & Development Rules, 2017 in respect of your Barwas Limestone Mine over an area of 8.91 ha located near Village-Barwas, in Sirmour district of HP State.

महोदय Sir,

The following provisions of the Mineral Conservation & Development Rules, 2017 were found violated in your above mine during the inspection made by the undersigned on 17.11.2019.

NATURE OF VIOLATION OBSERVED
Mining operation were not carried out in accordance with the approved modified mining plan vide letter no 614(2)/MP-B-19/11- DDN dated 15.03.2019 to the following extent: (i) As per proposal during the year 2018-19, it was proposed to carry out 02 DTH holes 20 mtrs depth each, but during the inspection it was observed no such DTH drilling carried out during the year 2018-19. (ii) As per proposal during the year 2018-19, it was proposed to carry out mining operation from 1458 to 1422 MRL. During the inspection it was observed that benches have not been developed from 1446 mrl downwards so far. The height of benches has also been observed up to 10 mtrs whereas as per approved modified mining plan it should be six meter
The holder of mining lease shall submit to the competent authority a yearly report as per the format specified by the Indian Bureau of Mines, before 1 st day of July every year setting forth the extent of protective and rehabilitative works carried out as envisaged in the approved mine closure plan, and if there is any deviation, reasons thereof: On perusal of office records it is observed that yearly report for the year 2018-19 has not been submitted to the competent authority by the holder of the lease in the prescribed in this office till date.
The holder of a mining lease shall, on or before the 30 th day of June every year submit to the authorized officer a digital copy along with a print copy of the surface geological plans and sections maintained under rule 32. However, the lessee has not submitted the copies of the plans and sections as per rules.

In this connection, it is brought to your kind notice that the above violations constitute an offence punishable under Rule 62 of MCDR 2017. Mining operations can be suspended as per rule 11(2) in case of non compliance and it constitutes non compliance of Rule 11(1) of MCDR, 2017.

4. You are advised to rectify the above violations immediately and intimate the compliance position to this office within 45 days from the date of issue of this letter.
