Mining operations are not carried out in accordance with the approved modified mining plan vide letter no. 614(2)/MS-A-138/2003-DDN Date:- 09.02.2018 to the following extent:
Area of around 1.05 ha is found less as compared to total area put to use by end of mining plan period, , including proposed area.
Thus additional FA need to be furnished as per Rule 27 of MCDR 2017 for such area.

The Holder of Mining lease Shall Maintain the Royalty assessment Register. Whereas the same was not found maintained

2. In this connection, it is brought to your kind notice that the above violations constitute an offence punishable under Rule 62 of MCDR 2017.
3. Mining operations can be suspended as per rule 11(2) in case of non compliance and it constitutes non compliance of Rule 11(1) of MCDR, 2017.
4. You are advised to rectify the above violations immediately and intimate the compliance position to this office within 45 days from the date of issue of this letter.
