विषय Violation of provisions of Mineral Conservation & Development Rules, 2017 in respect of your Bohar Limestone Mine over an area of 4.15 ha located near Village-Bohar Taluka-Paonta Sahib, in Sirmour district of HP State.

 Sir,

The following provisions of the Mineral Conservation & Development Rules, 2017 were found violated in your above mine during the inspection made by the undersigned on 23.02.2020 in the presence of Shri Ashok Das Mine Manager.

<u>RULE NO.</u>	<u>NATURE OF VIOLATION OBSERVED</u>
26(2)	The holder of mining lease shall submit to the competent authority a yearly report as per the format specified by the Indian Bureau of Mines, before 1 st day of July every year setting forth the extent of protective and rehabilitative works carried out as envisaged in the approved mine closure plan, and if there is any deviation, reasons thereof : On perusal of office records it is observed that yearly report for the year 2018-19 has not been submitted to the competent authority by the holder of the lease in the prescribed in this office till date.
33	The holder of a mining lease shall, on or before the 30 th day of June every year submit to the authorized officer a digital copy along with a print copy of the surface geological plans and sections maintained under rule 32. However, the lessee has not submitted the copies of the plans and sections as per rules.


- In this connection, it is brought to your kind notice that the above violations constitute an offence punishable under Rule 62 of MCDR 2017.
- You are advised to rectify the above violations immediately and intimate the compliance position to this office within 45 days from the date of issue of this letter.
