

विषय Sub: Violation of provisions of Mineral Conservation & Development Rules, 2017 in

respect of your Banour Limestone Mine over an area of 4.75 ha located near Village-

Banour Taluka-Paonta Sahib, in Sirmour district of HP State.

महोदय

Sir,

The following provisions of the Mineral Conservation & Development Rules, 2017 were found violated in your above mine during the inspection made by the undersigned on 24.02.2020 in the presence of Shri Deepak Chawla lessee.

RULE NO.	NATURE OF VIOLATION OBSERVED
11(1)	Mining operation were not carried out in accordance with the approved modified mining plan vide letter no 614(2)/76- DDN dated 10.08.2015 to the following extent: As per proposal during the year 2019-20, it was proposed to carry out mining operation in Eastern block from 1408 to 1385 mRL by formation of benches 6 mtr height. During the inspection height of benches has been observed up to 10 mtrs which is against the proposal and leads to unsystematic mining.
26(2)	The holder of mining lease shall submit to the competent authority a yearly report as per the format specified by the Indian Bureau of Mines, before1 st day of July every year setting forth the extent of protective and rehabilitative works carried out as envisaged in the approved mine closure plan, and if there is any deviation, reasons thereof: On perusal of office records it is observed that yearly report for the year 2018-19 has not been submitted to the competent authority by the holder of the lease in the prescribed in this office till date.
33	The holder of a mining lease shall, on or before the 30 th day of June every year submit to the authorized officer a digital copy along with a print copy of the surface geological plans and sections maintained under rule 32. However, the lessee has not submitted the copies of the plans and sections as per rules.

- 2. In this connection, it is brought to your kind notice that the above violations constitute an offence punishable under Rule 62 of MCDR 2017.
- 3. The Mining Operation can be suspended under rule 11(2) of MCDR 2017 in case of non compliance of rule 11(1) of MCDR 2017.
- 4. You are advised to rectify the above violations immediately and intimate the compliance position to this office within 45 days from the date of issue of this letter.
