

Violation of provisions of Mineral Conservation & Development Rules, 2017 in respect of your Chowki Mrigwal Limestone Mine over an area of 3.90 Ha (47-14 Bighas) located near Village: Chowki Mrigwal,

Mine Code: 38HPR10065

Tehsil: Paonta Sahib, District-Sirmour, H.P State..

The following provisions of the Mineral Conservation & Development Rules, 2017 were found violated in your above mine during the inspection made by the undersigned on 22.01.2020 in the presence of Shri Arun Grover, Lessee.

RULE NATURE OF VIOLATION OBSERVED	
NO. 11(1)	No holder of a mining lease shall commence or carry out mining operations in any area except in accordance with the mining plan approved, modified or reviewed by the Indian Bureau of Mines. On examination of office records proposed production in approved Review and Updation of Mining plan vide this office letter No-614(2)/MS-B-72/99-DDN dated 18-07-2016 vis-à-vis actual production as per statutory Returns is as follows: Year Proposed production (in tonnes) Actual production(in tonnes) 2015-16 20,000 20,276.6 Whereas the actual quantity is in excess of proposed quantity in approved Review and Updation of Mining Plan. Thus the mining operations were carried out in contraventions of the proposals in above referred mining plan.
26(2)	The holder of mining lease shall submit to the competent authority a yearly report as per the format specified by the Indian Bureau of Mines, before 1stday of July every year setting forth the extent of protective and rehabilitative works carried out as envisaged in the approved mine closure plan, and if there is any deviation, reasons thereof: On perusal of the office records it is observed that yearly report for the year 2018-19 has not been submitted to the competent authority by the holder of the lease in the prescribed in this office till date.

- 2. In this connection, it is brought to your notice that the above violations constitute an offence punishable under Rule 62 of MCDR 2017.
- 3. Mining operations can be suspended as per rule 11(2) in case of non compliance of rule 11(1).
- 4. May initiate appropriate action in accordance with any competent orders/directives etc.
- 5. You are therefore directed to show cause within a period of thirty (30) days from the date of issue of this letter, as to why you should not be prosecuted and / or why mining operation can be suspended under statutory provisions and/or why not any other action can be initiated in accordance with any competent orders/directives.

Please note that no further notice will be given to you in this regard.
