

Violation of provisions of Mineral Conservation & Development Rules, 2017 in respect of your Durga Limestone Mine over an area of 4.444 ha located near village Borli, Post-Sangrah, Tehsil -Renuka in Sirmour district of Himachal Pradesh State.

महोदय Sir,

The following provisions of the Mineral Conservation & Development Rules, 2017 were found violated in your above mine during the inspection made by Shri D.P.Sharma, Assistant Controller of Mines on 28.09.2019 in the presence of Shri D.K. Sinha, Mines Manager and violation letter of even number dated 25.10.2019 was issued for below mentioned rules of MCDR, 2017:

RULE NO.	NATURE OF VIOLATION OBSERVED
11(1)	Mining operations are not carried out in accordance with the approved modified mining plan to the following extent: As per proposal during the year 2018-19, it was proposed to carry out plantations 15 Nos of plants in 7.5 mtr barrier zone area within lease, but plantation was not carried out as per proposal.
26(2)	The holder of mining lease shall submit to the competent authority a yearly report as per the format specified by the Indian Bureau of Mines, before1 st day of July every year setting forth the extent of protective and rehabilitative works carried out as envisaged in the approved mine closure plan, and if there is any deviation, reasons thereof: On perusal of office records it is observed that yearly report for the year 2018-19 has not been submitted to the competent authority by the holder of the lease in the
33	The holder of a mining lease shall, on or before the 30 th day of June every year submit to the authorized officer a digital copy along with a print copy of the surfact geological plans and sections maintained under rule 32. However, the lessee has no submitted the copies of the plans and sections as per rules.
45(7)	The holder of a mining lease has submitted incomplete or wrong information in annual return 1. Part VI Section 2 dispatched quantity of limestone 583 tonnes shown but thi quantity not indicated in section 5 Sales/Dispatches affected for Domesti Consumption and for exports (Limestone). 2. Ex Mine Price is not correct. Ex Mine price is indicated less than cost of production

However in this reference on examining your letter No. Nil dated 24.11.2019, compliance of violation of Rule 26(2) and 45(7) of MCDR, 2017 was considered, proposed plantation for 2018-19 has not been carried out under Rule 11(1), whereas the digital copy along with print copy of Surface Geological Plan and Section has not been furnished to this office thus the compliance of Rules 11(1) and 33 have not been considered, thus the violation of Rules 11(1) and 33 of MCDR, 2017 still persist.

3. In this connection, it is brought to your kind notice that the above violations constitute an offence punishable under Rule 62 of MCDR 2017.

4. You are therefore directed to show cause within a period of thirty (30) days from the date of issue of this letter, as to why you should not be prosecuted for the above offences and / or why mining operation can be suspended under statutory provisions.

5. Please note that no further notice will be given to you in this regard
