Sub: Violation of provisions of MCDR, 2017 in respect of Kakatiya Limestone mine of M/s Kakatiya Cement Sugar & Industries Limited over an extent of 121.46 ha in Srinivasanagar (Village), Jaggayyapet (Mandal), Krishna District, Andhra Pradesh State

Sir,

The following provisions of Mineral Conservation and Development Rules, 2017 were found violated in the above mine during the inspection on 28.02.2018 by undersigned in the presence of M. Devanand Mines Manager.

Rule	No. Nature of Violation observed
Rule 11(1)	No holder of a mining lease shall commence or carry out mining operations in any area except in accordance with the mining plan approved, modified or reviewed by the Indian Bureau of Mines.
	However it has been observed that as per the document approved vide letter No. AP/KSN/MP/LST-28?Hyd dated 24.03.2017, it was proposed to drill 13 boreholes(390 meter) in 2017-18 but it has been observed that you have not drilled any borehole so far.
Rule 55(3)	The Mining Engineer appointed under rule must have atleast five years experience. However the Sri P Sanyasi Naidu appointed as Mining Engineer is not having the adequate experience of 5 years as per rule.

- 02. In this connection, it is brought to your notice that the above violation constitutes an offence punishable under rule 62 of MCDR, 2017. Besides, inability to comply the provisions of rule 11(1) is also liable for suspension of mining operations under provisions of rule 11(2) of MCDR'17.
- 03. You are advised to rectify the above violations immediately and intimate the position to this office within 45 (forty-five) days from the date of issue of this letter.
