Sub: Violation of provisions of MCDR, 2017 in respect of your Mukthyala Limestone mine over an extent of 368.35 ha Mukthyala Village, Jaggayapeta Mandal in Krishna District, Andhra Pradesh.

Sir,

The following provisions of Mineral Conservation and Development Rules, 2017 were found violated in the above mine during the inspection on 07.03.2018 by undersigned in the presence of Sri B Anil Kumar, Mining Engineer

Rule No.	Nature of Violation observed
<b>Rule 11(1)</b>	No holder of a mining lease shall commence or carry out mining operations in any area except in accordance with the mining plan approved, modified or reviewed by the Indian Bureau of Mines.

However it has been observed that against the approved proposal for plantation of 1500 saplings in 2017-18, you have undertaken plantation of 500 saplings so far.

**Rule 56(2)(f)**, The Geologist appointed as per rule is responsible for periodic updating of minerals resources as per drilled boreholes and calculation of ore reserves and it's grade. However the same data has not been found during the inspection.

02. In this connection, it is brought to your notice that the above violation constitutes an offence punishable under rule 62 of MCDR, 2017. Besides, inability to comply the provisions of rule 11(1) is also liable for suspension of mining operations under provisions of rule 11(2) of MCDR'17.

03. You are advised to rectify the above violations immediately and intimate the position to this office within 45 (forty-five) days from the date of issue of this letter.
