Sub: Violation of provisions of Mineral Conservation and Development Rules, 2017 in respect of your Ravirala limestone Mine over an extent of 60.72 ha situated in Ravirala village of Jaggayyapeta Mandal in Krishna district of Andhra Pradesh state.

The following provisions of Mineral Conservation and Development Rules, 2017 were found violated in the above mine during the inspection on 08.03.2018 by undersigned in the presence of Sri P Jani Reddy, Agent and Shri P Vidya Kiran, Mines Manager

Rule No.	Nature of Violation observed
Rule 55(3)	The Mining Engineer appointed under rule 55 must have atleast five years experience. However the Sri P Shashank appointed as Mining Engineer is not having the adequate experience of 5 years as per rule.
Rule 11(1)	No holder of a mining lease shall commence or carry out mining operations in any area except in accordance with the mining plan approved, modified or reviewed by the Indian Bureau of Mines. However noted that it was proposed to undertake regular environment monitoring but the last environment monitoring report was available for November 17.

02. In this connection, it is brought to your notice that the above violation constitutes an offence punishable under rule 62 of MCDR, 2017. Besides, inability to comply the provisions of rule 11(1) is also liable for suspension of mining operations under provisions of rule 11(2) of MCDR'17.

03. You are advised to rectify the above violations immediately and intimate the position to this office within 45 (forty-five) days from the date of issue of this letter.
