महोदय,

The following provisions of the Mineral Conservation and Development Rules, 2017 were found violated in your above mine during the inspection made on 22.04.2018 by the undersigned in presence of Shri Deepak Kalla, Mine Manager:

Rule No.	Nature of violation observed in detail
Rule 11(1)	The mining operations are carried out in violation of following provisions of approved Scheme of Mining (Approved on 20.05.2015): - (i) Ore to OB ratio proposal for the the year 2017-18 was 1:0.007 but actual it was 1:0.004; it shows that proporanate mine development has not been carried out.

02. In this connection, it is brought to your notice that the above violations constitute an offence punishable under Rule 62 of MCDR, 2017.
03. The mining operation can be suspended under rule 11(2) of MCDR, 2017 if compliance of rule 11(1) of MCDR 2017 is not found satisfactory.
04. You are advised to rectify the above violations immediately and intimate the position to this office on letter pad signed by the owner within 45 (forty-five) days from the date of issue of this letter.
