

विषय Sub: Violation of provisions of Mineral Conservation & Development Rules, 2017 in respect of your Chowgund Limestone Mine over an area of 2.37 ha located near Village Chowgund, Teh-Doru, District -Anantnag of J&K (UT).

महोदयSir,

On examination of the office records following provisions of the Minerals Conservation and

Development Rules, 2017 were found violated in your above mine:

RULE	NATURE OF VIOLATION OBSERVED		
NO. 11(1)	No holder of a mining lease shall commence or carry out mining operations in any area except in accordance with the mining plan approved, modified or reviewed by the Indian Bureau of Mines. Whereas on perusal of office records, it is found that for the month of April 2018 and May 2018 the mining operations were continued even after the expiry of mining plan, such details as following: Year Proposed production (in tonnes) Actual production (in tonnes) 2018-19 No proposal 40		
	The mining operation carried out in excess, without any proposal/approved mining plan.		
33	The holder of a mining lease shall, on or before the 30 th day of June every year submit to the authorized officer a digital copy along with a print copy of the surface geological plans and sections maintained under rule 32. However, the lessee has not submitted the copies of the plans and sections as per rules.		

In this connection, it is brought to your kind notice that the above violations constitute an offence 02. punishable under Rule 62 of MCDR 2017.

The mining operations can be suspended under rule 11(2) of MCDR, 2017 for non-compliance of the 03. violated rule 11(1).

You therefore directed to show cause notice within 30 days from the date of issue of this letter as to why 04. you should not be prosecuted for the above offence and or mining operation can be suspended under statutory provisions.
