

RULE NO.	NATURE OF VIOLATION OBSERVED		
11(1)	No holder of a mining lease shall commence or carry out mining operations in any area except in accordance with the mining plan approved, modified or reviewed by the Indian Bureau of Mines. Whereas on perusal of office records, it is found that the mining operations were continued even afte the expiry of mining plan with details as following:

	The mining operations carried out in excess, without any proposal/approved mining plan.		
33	The holder of a mining lease shall, on or before the 30 <sup>th</sup> day of June every year submit to the authorized officer a digital copy along with a print copy of the surface geological plans and sections maintained under rule 32. However, the lessee has not submitted the copies of the plans and sections as per rules.		

- In this connection, it is brought to your kind notice that the above violations constitute an offence 02. punishable under Rule 62 of MCDR 2017.
- The mining operations can be suspended under rule 11(2) of MCDR,2017 for non-compliance of the 03. violated rule 11(1).
- You therefore directed to show cause notice within 30 days from the date of issue of this letter as to why 04. you should not be prosecuted for the above offence and/or mining operation can be suspended under statutory provisions.
