02. In this connection, it is brought to your kind notice that the above violations constitute an offence punishable under Rule 62 of MCDR 2017.

03. The mining operations can be suspended under rule 11(2) of MCDR, 2017 for non-compliance of the violated rule 11(1).

O4. You therefore directed to show cause notice within 30 days from the date of issue of this letter as to why you should not be prosecuted for the above offence and/or mining operation can be suspended under statutory provisions.
