your Verinag Limestone Mine over an area of 4.0875 ha located near village Verinag, Teh.-

Doru, District - Anantnag, Union Territory-J&K.

महोदय Sir,

On examination of the office records, following provisions of the Mineral Conservation and Development Rules, 2017 were found violated at your above said mine & Violation letter of even number dated 21.10.2019 was issued for below mentioned violated rules;

RULE NO.	NATURE OF VIOLATION OBSERVED			
11(1)	(i)No holder of a mining lease shall commence or carry out mining operations in any area except in accordance with the mining plan approved, modified or reviewed by the Indian Bureau of Mines. On perusal of office records, it was observed that Scheme of Mining of this mine was approved by this office vide letter No-614(2)/MP-B-193/11-DDN dated 19.03.2012. It has been found that actual production is in excess to the proposed production as per following

	ii) On perusal of KML file it is found that actual workings are not as per approved Scheme of mining. Thus mining operations were not carried out as per approved Scheme of Mining. iii) Plantation was not carried out as per proposal during 2012-13 to 2016-17, as per para 10. E. of Approved Scheme of Mining.			
45(5)(b)	Monthly returns have not been submitted by the lessee to the Regional Controller/authorized officer of Indian Bureau of mines for February 2019 onwards.			
45(5)(c)	Annual return for the year ending 31st March 2019 has not been submitted by the lessee to the authorized officer of Indian Bureau of Mines.			

2. However in reference to the aforesaid VL no reply has been received. Thus the violation still persists.

3. In this connection, it is brought to your kind notice that the above violations constitute an offence punishable under Rule 62 of MCDR 2017.

4. Mining operations can be suspended under rule 11(2) of MCDR, 2017 in case of non-compliance of above Violated Rule of MCDR, 2017, as it Constitutes non-compliance of Rule 11(1) of MCDR 2017.

5. The mining operation may be advised for suspension as per provision of Rule 45(7) MCDR 2017 in case of noncompliance of rule 45(5) (b) & 45(5) (c) of MCDR, 2017.

6. You are therefore directed to show cause within a period of thirty (30) days from the date of issue of this letter, as to why you should not be prosecuted for the above offences

7. Please note that no further notice will be given to you in this regard.
