विषय Sub: Violation of provisions of Mineral Conservation & Development Rules, 2017 in respect of your Manal Limestone Mine over an area of 172.3 ha located near Village Manal, District- Sirmour, H.P. State.

महोदय Sir,

Following provisions/rules of the Mineral Conservation and Development Rules, 2017 were found violated in your above mine during the inspection made by the undersigned on 14th and 15th Sep 2019 in the presence of Shri P.K Sinha , Mine Manager and Shri Kumbha Ram, Mining Engineer.

NATURE OF VIOLATION OBSERVED

26(2)

The holder of mining lease shall submit to the competent authority a yearly report as per the format specified by the Indian Bureau of Mines, before 1st day of July every year setting forth the extent of protective and rehabilitative works carried out as envisaged in the approved mine closure plan, and if there is any deviation, reasons thereof :
On perusal of office records it is observed that yearly report for the year 2018-19 has not been submitted to the competent authority by the holder of the lease in the prescribed in this office till date.

The holder of a mining lease shall, on or before the 30th day of June every year submit to the authorized officer a digital copy along with a print copy of the surface geological plans and sections maintained under rule 32.
However the lessee has not submitted the copies of the plans and sections as per rules so far.

45(7)

The holder of a mining lease has submitted incomplete or wrong information in annual return
1. Ex Mine Price is not correct, necessary deductions are not made for calculation of EMP.
2. During the inspection it was observed that Cost of production at Part-VII of the annual return is not correct. Transportation cost of the outside lease is not deducted from the cost of production.
3. Part-VI (Production, Dispatches And stock) In the part VI (2) Production and dispatch of LD grade limestone is indicated.

- 54 The holder of a mining lease shall maintain the royalty assessment register, where the same was not found maintained.
- 54(a) (a) The holder of a mining lease shall maintain Details of contribution made to District Mineral Foundation and National Mineral Exploration Trust, where the details was not found maintained.
2. However in this reference on examining your letter No. RCF/Min/IBM/2019 dated 03.10.2019, compliance of violation of Rules 26(2), 45(7), 54 and 54(a) of MCDR,2017 were considered, whereas compliance of Rule 33 has not been considered and thus violation of rule 33 still persist.
3. In this connection, it is brought to your kind notice that the above violations constitute an offence punishable under Rule 62 of MCDR 2017.
4. You are therefore directed to show cause within a period of thirty days (30) from the date of issue of this letter, as to why you should not be prosecuted for the above offences.
5. Please note that no further notice will be given to you in this regards.
