Sub Violation of provisions of MCDR 2017 in respect of your **Sivalarpatti Limestone Mine** over an area of 150.11 hect Sivalarpatti –village,Tuticorin –District of Tamilnadu.

Sir,

The following provisions of the Mineral Conservation and Development Rules 2017 were found violated in your above referred- mine during the inspection on **15.07.17** by the undersigned.

Rule	Nature of Violation
11(2)	Modifications to the Approved Mining Plan was approved vide letter No.TN/TKD/LST/MP-208.MDS dated 16.12.2016 for the period from 2016-17 to 2019-20. The deviations observed in mining operations vis-à-vis approved document is given below :- It is proposed to develop the pit and to do production on section 29 and 30 up to the Safety barrier of the pond. But during the inspection it was observed that the workings are beyond the safety barrier of the pond which is against the approved proposals and thus caused violation. Further, you have not maintained boundary pillars for the mining lease area around the pond.

02. In this connection, it is brought to your notice that the above violations constitute an offence punishable under **Rule 62** of Mineral Conservations and Development Rules, 2017.

03. You are advised to rectify the above violations immediately and intimate the position to this office within 45 (forty five) days from the date of issue of this letter.
