Violation of provisions of Mineral Conservation & Development Rules, 2017 in respect of your Bharil Limestone Mine over an area of 4.48 ha located near village Bharli in Tehri Paonta Sahib district of Himachal Pradesh State.

The following provisions of the Mineral Conservation and Development Rules, 2017 were found violated in your above mine during the inspection made by Shri. S. Saklani, Assistant Mining Geologist on 16.04.2019 in the presence of Shri Neeraj Chaudhary, represnative of lessee.

RULE NO.	e by Shri. S. Saklani, Assistant Mining Geologist on 16.04.2019 in the presence of Shri Neeraj Chaudhary, representive of resection.  NATURE OF VIOLATION OBSERVED
12 (4A)	According to this rule, in case of mining lease covered under sub-section 8A of the MMDR Act, 1957 where the date of expiry of the period of such lease is on 31.03.2020, the holder of such mining lease shall carry out General Exploration (G2) over the entire mineralized area under the mining lease before the 1 <sup>st</sup> day of April, 2019. During the inspection it was observed that no such exploration has been carried out.
26(1)	According to this rule, the holder of a mining lease shall have the responsibility to ensure that all protective measures inculding recalmation and rehabilitation works have been carreid out in accordance with the approved mine closure plan or with such modification as approved by the competent authority.  The holder of a mining lease shall have the responsibility to ensure that the protective measures including reclamation and rehabilitation works have been carried out in accordance with the approved mine closure plan or with such modifications as approved by the competent authority. Mining lease holder has submitted such proposals in Progressive Mine closure plan time to time along with the mining plan. Whereas on the basis of site inspection mentioned herein above and also on examination of the office records, plans and sections etc. no such proposals have been implemented till date pertaining to the protective, reclamation and rehabilitation measures as envisaged in the Progressive Mine closure plan contained in the approved mining plan in respect of which financial assurance has been furnished.
26(2)	The holder of mining lease shall submit to the competent authority a yearly report as per the format specified by the Indian Bureau of Mines, before 1 <sup>st</sup> day of July every year setting forth the extent of protective and rehabilitative works carried out as envisaged in the approved mine closure plan, and if there is any deviation, reasons thereof, whereas the yearly report has not been furnished by the holder of the mining lease as per rules.
45(5)(b)	Monthly returns have not been submitted by the lessee to the Regional Controller/authorized officer of Indian Bureau of Mines for February, 2019 onwards.

- In this reference, on perusal of the office record it is observed that neither you have responded to violation letter nor complied the above violated Rules. However, on perusal of office record compliance of Rule 45(5)(b) has been observed . thus the violation of rules12(4A), 26(1) and 26(2) still persists.
- In this connection, it is brought to your kind notice that the above violations constitute an offence punishable under Rule 62 of MCDR 2017.
- 4. You are therefore directed to show cause within a period of thirty (30) days from the date of issue of this letter, as to why you should not be prosecuted and / or why mining operation should not be suspended for the above offence.
- 5. Please note that no further notice will be given to you in this regard.
