In exercise of the powers conferred by clause (b) of sub-section (2) of section 5 of the Mines & Minerals (Development & Regulation) Act, 1957 and clause (2) of Rule 17 of the Minerals (Other than Atomic and Hydro Carbons Energy Minerals) Concession Rules, 2016 read with Government of India Order No.S.O.445(E) dated 28.04.1987 and S.O. 1857(E) dated 18th May, 2016; you are hereby informed that the Review of Mining Plan submitted by you is '**NOT APPROVED**' for the following reason:-

- The ML boundary as shown in all the submitted plans are not matching with the ML boundary as shown in the last approved review of mining plan document. It has been observed that the lessee has applied to the State Govt. for authentication of its submitted revised ML area map. All the submitted drawings are on the basis of above revised ML area map submitted for its authentication to the State Govt. But, the same has not been authenticated by the State Govt.

Any further submission shall be considered as a fresh draft submission.
