Sub: Violation of provisions of Mineral Conservation & Development Rules, 2017 in respect of your Hutti Gold Mine (ML.NO. 2671) in Raichur-Dist of Karnataka State Sir,

The following provisions of Mineral Conservation & Development Rules, 2017 were found violated during inspection of your above mine on 28<sup>th</sup> to 30<sup>th</sup> January 2019 by the undersigned in presence of Dr T.K. Abdul Rahim, Manager (Exploration) and Shri Somesh K.V., Dy. Manager (Mine) & Mining Engineer.

Rule No.	Nature of violation observed
11 (1)	The mining operations are not being carried out as per the approved Review and updation of Mining Plan No-279/356/92/BNG, dated 9/04/2018 to the extent as mentioned below.
	(i)Cumulative total of 5,314m primary and stope development were undertaken upto Sept. 2018 (as per submitted quarterly return) against proposals of 3,835m of on-lode & off-lode development for year 2018-19.
	(ii) Around 15 m decline sinking completed so far against the proposals of 45m for year 2018-19.

35 (2)	The copy of high resolution satellite image obtained from CARTOSAT-2 satellite LISS-
	IV sensor on the scale of cadastral map as on 31/3/2018 covering the mining lease
	and an area of two kms from lease boundary has not been submitted so far.
45(7)	On examination of submitted Annual Return for year 2017-18, it is found to be in-
	complete due to following deficiencies.
	(i)Part-I (Item No-12): the surface area utilization figures were not matching with
	latest approved Review and updation of Mining Plan dated 9/04/2018
	(ii) Part-II-A: The value of fixed assets mentioned at on-line return should be checked
	and corrected w.r.t. unit.
	(ii)Part-III :-Payment of dead rent should be checked and clarify. Further, DMF &
	NEMT payment have not been properly mentioned / reflected under item no-5.
	(iii) Part-V(item No-3):-:- The reserves and resources figures were not matching with
	latest approved Review and updation of Mining Plan dated 9/04/2018.
	(iv) Part-V (item No-4):-Underground development figures were not matching with
	the corresponding the quarterly returns for period ending March-2018.
	(vi) Part-V (item No-5):-All machineries details were not furnished at on-line return.
	(vi)Part-VI: Ex-mine price shall be per unit cost of production in case of captive
	mines as per rule 45 (8) (V).
47	Notice of sinking of surface boreholes in form-I along with borehole location plan
	has not been submitted, so far.

- 02. In this connection, it is brought to your notice that the above violations constitute an offence, punishable under Rule 62 of MCDR, 2017.
- 03. The mining operations can be suspended under rule 11(2) of MCDR 2017, if compliance of rule 11(1) is not found satisfactory.
- 04. You are advised to rectify the above violations immediately and intimate the position to this office within 45 (forty five) days from the date of issue of this letter.
