No further extension of time in this regard will be entertained and the document will be considered for rejection if not submitted within the above due date and deficiencies not attended properly.

Scrutiny Comments on Draft report for Modification in Approved Review of Mining Plan with Progressive Mine Closure Plan of Nongtraï Limestone Mines over an area of 100.00 Ha. in village-Nongtraï, Mawsynram Block, Shella Confederacy, Dist- East Khasi Hills, Meghalaya of M/s. Lafarge Umiam Mining Private Ltd, prepared by Sri Sandeep Taneja & submitted under Rule 17 (3) of MCR 2016 & 23 of MCDR 2017.

- 1.0 Mining plan needs to be prepared & submitted as per the new and updated prescribed format given in “IBM manual for appraisal of Mining Plan – 2017. Accordingly all the consents/ certificates enclosed needs to be as per the format given in the above manual.
- 2.0 It has been stated that the ML stands extended up to 2.1.2032. The same needs correction and supporting document may be enclosed therewith.
- 3.0 In the introduction chapter a brief history of the mining lease to be given depicting all the statutory clearances/ court cases (if any) etc. with documentary evidence from the grant of the mining lease to as on date in chronological order including this draft submission.
- 4.0 In the introduction/Preamble chapter only details of the lessee may be given along with other details as cited in Sl. No.3.0. No other details are required.
- 5.0 The long term agreement between M/S LUMPL and M/S LHBL may be detailed enclosing the supporting documents and justifying whether the export/sale is on Arms-length basis or not. The same shall be detailed in chapter of end use.
- 6.0 Production proposal calculation may be enclosed duly supported with Plan and sections.
- 7.0 Reserve and resource calculation sheet may be enclosed with the document duly supported with Plan and sections.
- 8.0 The proposal of future exploration shall be up to the bottom of mineralization. No specific depth shall be entertained.
- 9.0 CCOM circular no 2/2010, amendment thereafter regarding geo-referenced lease map and boundary pillars is to be implemented.
- 10.0 The details of core boreholes drilled in the Mining Lease Area shall be enclosed as annexure and shall be signed by the geologist.
- 11.0 Permission regarding use of ANFO/SMS may be enclosed with the document.

- 12.0 Annexure-14 showing vibration monitoring should be modified with respect to minimum velocity (mm/s) so as to register the correct results therein.
- 13.0 Permission regarding storage of explosives may be enclosed.
- 14.0 Key Plan and Environment Plan shall be prepared as per the extant provisions specified under rule 32(5(a) of MCDR-2017.
- 15.0 All existing surface features must be clearly shown in the surface plan.
- 16.0 The Non-perennial nalah may be clearly shown in the surface plan which exists towards the north of Mining Lease.
- 17.0 Name of Geologist with signature shall be mentioned in following plans:
 - a) Surface Geological Plan
 - b) Geological Cross section and Longitudinal Section

- 18.0 Name of Surveyor & Mines Manager with respective signatures should be mentioned in following plans:
 - a) Key Plan
 - b) Surface Plan
 - c) Environmental Plan
 - d) Financial Area Assurance Plan
