The following provisions of the Mineral Conservation & Development Rules 2017 were found violated in your above mine during the inspection carried out by the undersigned in presence of Shri. A Venkateshwar Reddy, Sr. Manager Mining & Shri. Sreekanth Reddy, Mines Manager on 25.04.2019.

Rule	Nature of violations observed
11(1)	Approved Review & updation of Mining Plan with PMCP was approved vide letter no.279/736/2002/BNG/759 dated 31.03.2017 for a period of 2017-18 to 2021-2022. The deviation observed in mining operation vis-a-vis approved document are given below:
	(i) The location of the waste dump which was proposed in location E 664951-665080 & N 1675289-1675389 has been changed to E665075-664950 & N1675355 - 1675270.
	(ii) As per PMCP 2000 No of saplings were supposed to be planted for the year 2018-19,but only 1600 saplings have been planted as per the records.

- 02. In this connection it is brought to your notice that the above violations constitute an offence punishable under Rule 62 of MCDR 2017. Further, the violation of Rule 11(1) may also attract provisions of Rule 11(2) of MCDR, 2017 regarding suspension of mining operations till the compliance of violations.
- 03. You are advised to rectify/explain the above violations immediately and intimate the position to this office within 45 (Forty Five) days from the date of issue of this letter.
