The following provisions of Mineral Conservation and Development Rules, 2017 (MCDR, 2017), were found violated in your above mine during the inspection of the mine on 21.04.2017 by the undersigned and accompanied by Sri Ponnu Swamy, Manager(Mines), Sri D V Akhil Kalyan, Mining Engineer and Sri Yasayya Surala, Mines Foreman of your mine and communicated to you vide this office letter referred at sl. no.(i) by giving you 45 (Forty five) days time period for rectification of the same.

You are, therefore, directed to show cause within a period of 30 (thirty) days from the date of issue of this letter, as to why you should not be prosecuted for the above offence and or mining operations be suspended under Rule 11(2) of MCDR, 2017 in the mine till compliance of the aforesaid violation.
- 05. Please note that no further notice will be given to you in this regard.
