The following provisions of Mineral Conservation and Development Rules 1988 (MCDR, 1988), were found violated in your above mine during the inspection of the mine on 22.04.2017 by the undersigned and accompanied by Sri B S P Raju, Agent, Sri P Jani Reddy, Mines Manager, Sri P S Murthy, Geologist, of your mine.

In this connection, it is brought to your notice that the above violation constitutes an offence punishable under rule 62 of MCDR, 2017, further the mining operations can be suspended under rule 11(2) and initiate action as per rule 47(a) of MCDR, 2017, if compliance of rules 11(1) and 45(5) is not found satisfactory.
- 04. You are advised to rectify the above violations immediately and intimate the position to this office within 45 (forty-five) days from the date of issue of this letter.
