The following provisions of Mineral Conservation and Development Rules 2017 (MCDR, 2017), were found violated in your above mine during the inspection of mine for processing of review of mining plan on 06.10.2017 by the undersigned accompanied by Dr P VikayaKumar, Qualified Person, Mr.Mohammed Khasim Basit, Manager, Shri P S Bharathi, Geologist & Shri Cellaswamy KrishnaKumar, Supervisor of your organisation.

In this connection, it is brought to your notice that the above violation constitutes an offence punishable under rule 62 of MCDR, 2017, further the mining operations can be suspended under rule 11(2) and 45(7) (a) (i) of MCDR, 2017, if compliance of rules 11(1) and 45(7)(a) is not found satisfactory.
- 03. You are advised to rectify the above violations immediately and intimate the position to this office within 45 (forty-five) days from the date of issue of this letter.
