Sir,

Regional Controller of Mines along with the undersigned inspected your above mine in the presence of your mine officials Sri Sharad Kumar (Mines Manager) and Sri D. Samadar (Mining Engineer) and violation letter under the provisions of MCDR 2017 vide letter of even number dated 13.02.2018 has been issued by this office.

In response to the above violation letter, a compliance letter vide letter No. BKJ/Q/Min/255/17-18/390, dated 19.02.2018 and BKJ/Q/Min/255/17-18/1772/001, dated 01.04.2018 have been received by this office. The stated compliances against the violations pointed out are not satisfactory.


02. In this connection, it is brought to your notice that the above violations constitute an offence punishable under Rule 62 of Mineral Conservation and Development Rules, 2017.

03. The mining operations can be suspended under rule 11(2), if compliance of rule 11(1) is not found satisfactory.

04. You are therefore, directed to show cause with in a period of 30 (Thirty) days from the date of issue of this letter, as why should not be prosecuted for the above offences.

05. Please note that no further notice will be give to you in this regard.


