**Subject:** Violation of provisions of Mineral Conservation and Development Rules, 2017, in respect of your Jamunanagar limestone mine over an area of 35 Ha. in Dima Hasao district of Assam.

Sir,

Undersigned has issued violation letter of even number dated 31.10.17 for below mentioned rules of Mineral Conservation & Development Rules, 2017.

Rule Number	Nature of violations observed
12(1), 13(1), 13(2), 14(4), 32(1)(a), 32(5)(b), 37(1) & 37(2) of MCDR 2017	Violation pointed out under rule 32(1)(a) & 32(5)(b) have been complied vide your letter dtd. 9.1.18 and for compliance of the violations pointed out under other rules, a time frame of 3 months was desired vide your letter dtd. 29.11.17. However, till date the same has not been complied.

02. In this connection, it is brought to your notice that the above violations constitute an offence punishable under Rule 62 of Mineral Conservation and Development Rules, 2017.

03. The mining operations can be suspended under rule 11(2), if compliance of rule 11(1) is not found satisfactory.

04. You are, therefore, directed to show cause within a period of 30 days from the date of issue of this letter, as to why you should not be prosecuted for the above offences.

05. Please note that no further notice will be given to you in this regard
